Ngày 08/7/2022, Văn phòng Kinh tế Văn hóa Việt Nam tại Đài Bắc nhận được công văn số 1111301860 ngày 06/7/2022 của Cơ quan Quản lý Thực phẩm và Dược phẩm Đài Loan (TFDA) trực thuộc Cơ quan quản lý Y tế và phúc lợi Đài Loan (MOHW) thông báo về việc Đài Loan sẽ chính thức sử dụng Hệ thống quản lý số hóa thực phẩm nhập khẩu vào Đài Loan từ ngày **01/8/2022**. Văn phòng Kinh tế Văn hóa Việt Nam tại Đài Bắc qua nghiên cứu, xin trao đổi lại với quý Bộ như sau:

Theo thông báo của TFDA, kể từ ngày này, đơn xin kiểm tra đánh giá tính hệ thống các sản phẩm xuất khẩu vào Đài Loan sẽ phải được nộp theo hình thức trực tuyến. Phía Đài Loan sẽ không thụ lý hồ sơ bằng giấy tờ/vấn bản các đơn xin kiểm tra đánh giá tính hệ thống (bao gồm việc tăng mới thêm các doanh nghiệp xuất khẩu vào Đài Loan). Ngoài ra, qua trao đổi, TFDA cho hay, các hồ sơ đã nộp trước ngày 01/8 năm nay sẽ không cần phải khai lại trên Hệ thống.

Thông báo của TFDA cũng cho biết, theo quy định tại khoản 1 Điều 35 Luật Quản lý vệ sinh an toàn thực phẩm, để quản lý các sản phẩm có mức độ rủi ro cao về an toàn thực phẩm, trước khi xuất khẩu vào Đài Loan cần tiến hành kiểm tra đánh giá tính hệ thống, MOHW đã ban hành Biện pháp thực thi kiểm tra đánh giá tính hệ thống thực phẩm xuất khẩu (sau đây gọi tắt là Biện pháp). Theo quy định tại điều 3 của Biện pháp này, phạm vi các sản phẩm cần tiến hành kiểm tra đánh giá tính hệ thống bao gồm “sản phẩm thịt”, “sản phẩm thủy sản”, “chế phẩm sữa”, “trứng”, “dầu mỡ động vật” và “sản phẩm xuất xứ từ hươu khác”. Các nước xuất khẩu cần có đơn xin kiểm tra đánh giá tính hệ thống và được thông qua thì các sản phẩm này mới được xuất khẩu vào Đài Loan.

Để thúc đẩy số hóa các trình tự và quy trình kiểm tra đánh giá tính hệ thống đối với thực phẩm nhập khẩu, TFDA đã xây dựng Hệ thống quản lý số hóa thực phẩm nhập khẩu vào Đài Loan (*Imported Food Digital Management System – IFDM*), các đối tác có thể thông qua IFDM để xin tiến hành kiểm tra đánh giá tính hệ thống.

Trước đó, để thúc đẩy việc số hóa các thủ tục kiểm tra có hệ thống đối với thực phẩm nhập khẩu, nâng cao hiệu quả quản lý thực phẩm nhập khẩu, ngày 17/5/2022, TFDA đã tổ chức lớp tập huấn về Hệ thống quản lý kỹ thuật số thực

phẩm nhập khẩu theo hình thức trực tuyến. TFDA gửi kèm Sổ tay hướng dẫn thao tác IFDM và phụ lục Q&A như đã tập huấn ngày 17/5/2022 để các đối tác tham khảo.

Văn phòng Kinh tế Văn hóa Việt Nam tại Đài Bắc kính gửi quý Bộ toàn văn thông báo của phía Bạn như phụ lục đính kèm để quý Bộ nghiên cứu xử lý./.

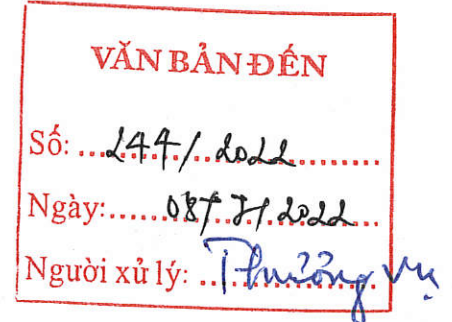

主旨：本署輸入食品數位化管理系統訂於111年8月1日正式啟用，自該日起，各國輸臺產品系統性查核申請案採線上提交，屆時系統性查核案（包括新增輸臺生產設施等）將不再受理紙本申請，詳如說明，請查照。

說明：

- 一、依據食品安全衛生管理法第35條第1項規定，衛生福利部為管控食品安全風險程度較高之品項，得於輸入前實施系統性查核，特訂定「輸入食品系統性查核實施辦法」（下稱系統性查核辦法），依據系統性查核辦法第3條規定，應實施系統性查核之產品範圍包含「肉類產品」、「水產品」、「乳製品」、「蛋品」、「動物性油脂」及「其他鹿來源產品」，輸出國應申請系統性查核並通過後，該些產品始得輸臺。

二、為推動輸入食品系統性查核申請作業及程序數位化，本署已建置輸入食品數位化管理系統（IFDM），各國可透由IFDM提出系統性查核案申請。檢附111年5月17日本署辦理「輸入食品數位化管理系統」教育訓練問答集及IFDM操作手冊如附件。

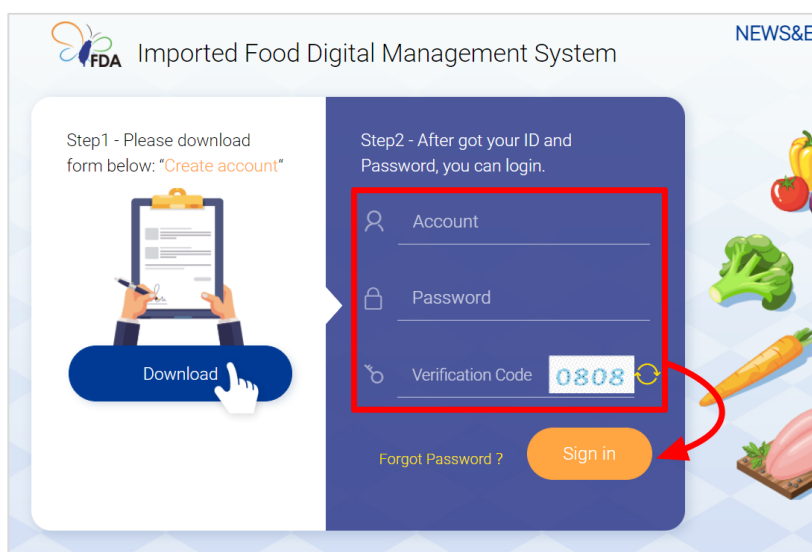
## 1.1 System login

Step1: Input system website [ifdm.fda.gov.tw](http://ifdm.fda.gov.tw) in the browser.

Step2: Click “Sign in” in the “Foreign competent authority”.



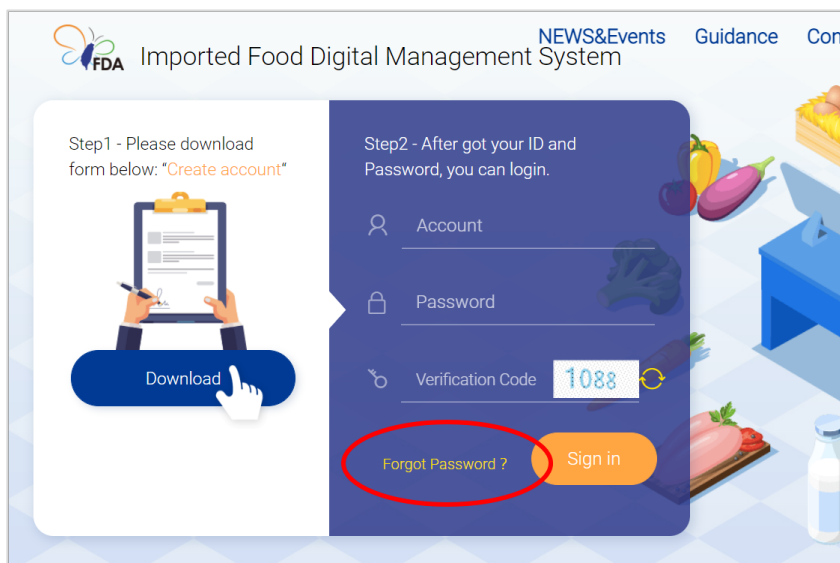
Step3: key in the personal ID, password and verification code in log-in window; after that, click “Sign in”.



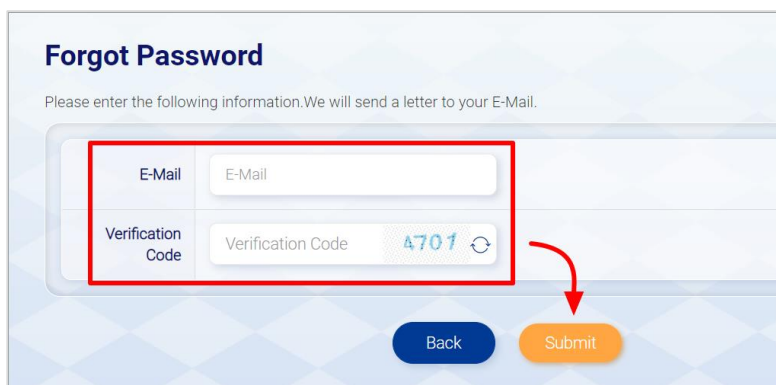

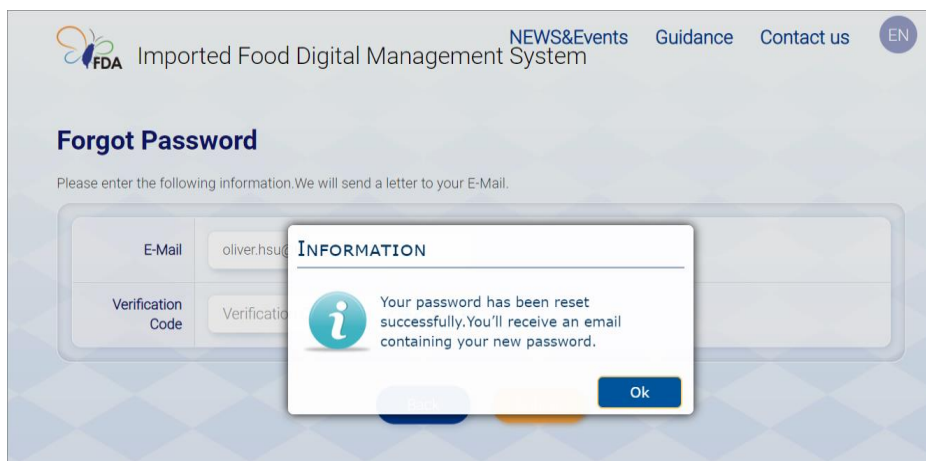
Step1: Click “Forgot Password ? ”



Step2: Key in the e-mail address and verifying code when inputting the registered ID; after that, click “Submit”.

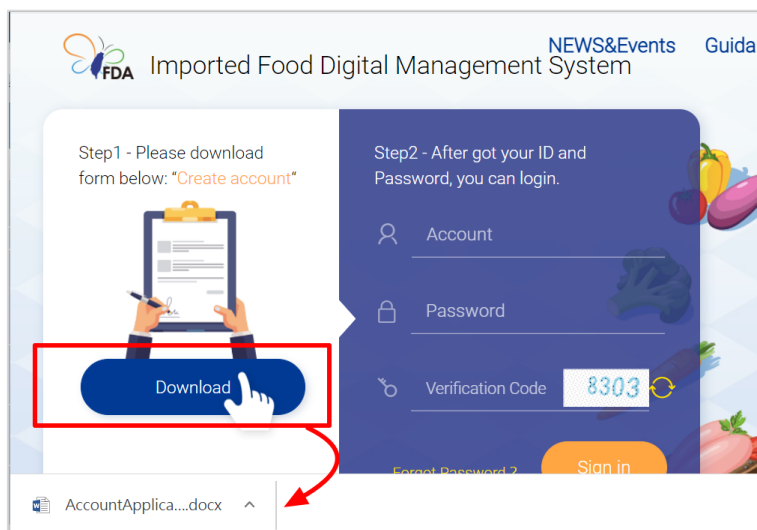


Step3: Go to personal email box to receive the password.

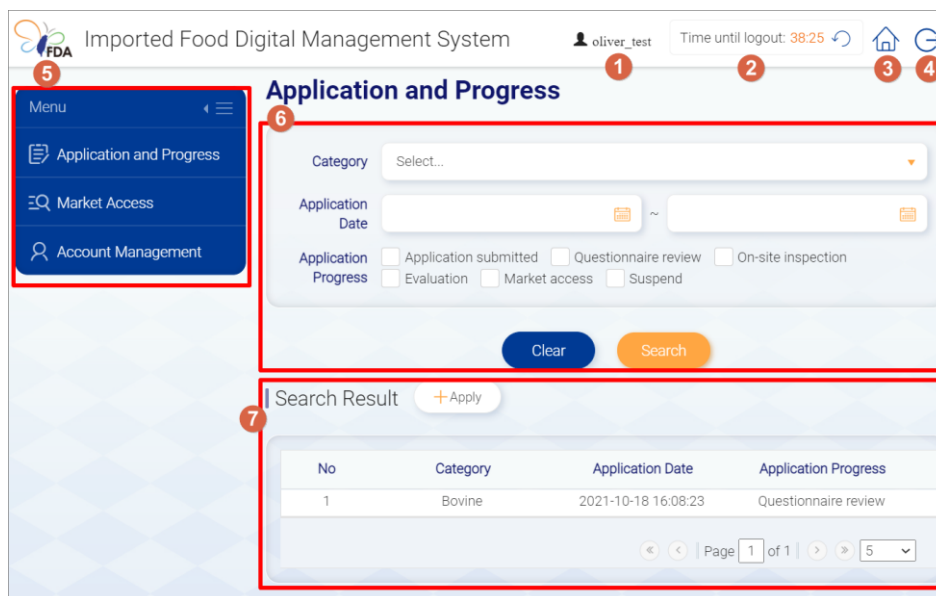

- **Account Management**



請至「輸入食品數位化管理系統」(<https://ifdm.fda.gov.tw/Home/SignIn>) 首頁並點選「sign in」下載帳號申請書，填寫完成之後，可以正式公文函送衛生福利部食品藥物管理署(以下稱食藥署)提出帳號申請，或如駐臺機構已知食藥署相關承辦人聯絡電郵，亦可以電郵提出申請，為免承辦人因業務眾多而漏信，建議如以電郵提出申請者，請同時來電通知。

**Q2. 承上，每個申請國(意指欲輸出實施系統性查核之產品範圍至臺灣的國家或地區)可以申請幾個帳號？**

**說明：**

一個申請國可申請多組帳號，同類產品種類限申請一組帳號(例如：豬肉、牛肉、禽肉共用一組帳號；水產品一組帳號)，且限定由申請國官方單位提出申請。

**Q3. 承上，申請後帳號通用於所有產品類別嗎？**

**說明：**

1. 提出帳號申請時應同時告知預計申請何種產品類別之系統性查核申請，待食藥署審核並開通後，申請國始能上系統填寫問卷，並非所有產品類別均可填寫。
